


You have to deposit the amount of TDS so deducted through challan cum-statement in form 26QB. This form can only be generated through official web site of the IT department. Only duly filled form generated though web-site can be used for payment of TDS.






Should I halso file any return after payment of TDS?



No, you need not file any return.





You have to issue a certificate in form 16B to the payee within 15 days from the due date for furnishing the challan-cumstatement in form no 26QB under rule 31A after generating & down loading from web-portal. The amount of TDS deposited by you will also be reflected in the statement of seller in IT web site in his form 26AS
